An Oxfam report in 2022 revealed that the top 10% of the world's wealthiest individuals control over 76% of global wealth, while more than 2.5 billion people live on less than \$2.50 a day (Oxfam, 2022). This crisis not only exacerbates economic conditions for many individuals but also generates social tensions that could lead to mass migration due to instability.

In addressing these evolving global challenges, the relationship between economic development and law is becoming increasingly relevant. Amid efforts to achieve the Sustainable Development Goals (SDGs), economic policies and legal regulations interact in creating environments conducive to sustainable growth. For example, changes in international trade policies and investment regulations significantly affect economic stability, which in turn impacts social welfare (Rodrik, 2018).

Moreover, environmental law and economic policy are now nearly inseparable. The demand for supporting sustainable business practices, meeting environmental standards, and protecting natural resources requires a robust legal framework. International agreements, such as the Paris Agreement, establish parameters that nations must follow, influencing economic policies at both national and local levels (United Nations Framework Convention on Climate Change [UNFCCC], 2016).
